a. To authorize District Administration to repair or replace the Athletics Department whirlpool equipment, at a cost not to exceed \$6,500.

Motion carried unanimously.

Thomas F. Durkin, of VEBH Architects, PC, provided the members with an overview of draft Freeport Area Athletics Complex Project construction documents, a project cost estimate, and an approximate project timeline.

b. To approve the Freeport Area Athletics Complex Project's final construction documents, with costs not to exceed \$4.48 million, and to authorize the Administration to advertise for receipt of public bids.
