An Affiliation Agreement with Clarion University of Pennsylvania, for the placement of student teachers as part of the University's education program, during the 2018-2019 through 2021-2022 school years.

The acceptance of 2017-2018 classroom grants from the Freeport Area School District Foundation, in the total amount of \$2,345.

Acceptance of an Innovative Classroom Grant (2018) Award from the PPG Foundation, in the amount of \$1,000, to be used to cover expenses related to the Science Program at the Freeport Area Middle School.
